6 Accidental release measures

Environmental precautions

Methods and materials for containment and cleaning up

- It is recommended that emergency personnel wear positive pressure self-contained breathing apparatus and wear anti-static clothing.
- 2 In case of small amount of spillage, use clean non sparking tools to collect absorption materials.

3	In case of large amount of spillage, construct cofferdam or dig a hole to collect the spillage. Use foam cover to reduce evaporation. Water spray mist can reduce evaporation, but can not reduce the flammability of the leakage in the restricted space.
4	Collect absorbent material using a clean, non-sparking tool.
5	Cover with anti-solvent foam to reduce evaporation.
6	Cover with DRY earth, DRY sand or other non-combustible material followed with plastic sheet to minimize spreading or contact with rain.
7	Water spray reduces evaporation but does not reduce the flammability of spills in confined spaces.
8	Cut off the source of the leak as much as possible.
9	Keep leaks in a ventilated place.

Absorb spilled material in dry sand or inert absorbent. In case of large amount of spillage, contain a spill by bunding.
 Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container.
