- 4 Collect absorbent material using a clean, non-sparking tool.
- 5 Cover with anti-solvent foam to reduce evaporation.
 - Cover with DRY earth, DRY sand or other non-combustible material followed with plastic sheet to minimize spreading or contact with rain.
- 7 Water spray reduces evaporation but does not reduce the flammability of spills in confined spaces.
- 8 Do not touch or cross spills.
