# **Description of first aid measures**

### Methods and materials for containment and cleaning up

- 1 Cut off the source of the leak as much as possible.
- 2 Keep leaks in a ventilated place.
- Absorb spilled material in dry sand or inert absorbent. In case of large amount of spillage, contain a spill by bunding.
- 4 Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.
- Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container.
