Methods and materials for containment and cleaning up

- Cut off the source of the leak as much as possible.

- 4 Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.
- 5 Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container.
