## 6 Accidental release measures

## Personal precautions, protective equipment and emergency procedures

1	Use personal protective equipment, do not breathe gas/mist/vapour/spray.
2	Ensure adequate ventilation. Remove all sources of ignition. Take precautionary measures against static discharges.
3	Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

## Environmental precautions

1	Prevent further leakage or spillage if safe to do so.
2	Discharge into the environment must be avoided.

## Methods and materials for containment and cleaning up

1	Cut off the source of the leak as much as possible.
2	Keep leaks in a ventilated place.
3	Absorb spilled material in dry sand or inert absorbent. In case of large amount of spillage, contain a spill by bunding.
4	Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.
5	Contain spillage, and then collect with an electrically protected vacuum cleaner or by wet-brushing and place in container.

## 7 Handling and storage

### Precautions for safe handling

1	Handling is performed in a well ventilated place.
2	Wear suitable protective equipment.
3	Avoid contact with skin and eyes.
4	Keep away from heat/sparks/open flames/ hot surfaces.

### Conditions for safe storage, including any incompatibilities

1	Keep containers tightly closed.
2	Keep containers in a dry, cool and well-ventilated place.
3	Keep away from heat/sparks/open flames/hot surfaces.
4	Store away from incompatible materials and foodstuff containers.
